EXPLANATORY MEMORANDUM TO NOTICE OF FORESTERS FINANCIAL LIMITED 2025 ANNUAL GENERAL MEETING

Election of Directors

Resolution 1: Election of Andrew Baxter as a Director

THAT Andrew Baxter, having retired from his office as a Director of Foresters Financial Limited in accordance with clause 10.8 of the Constitution and having offered himself for reelection, be re-elected as a Director of Foresters Financial Limited.

Resolution 2: Election of Nicolle Rantanen as a Director

THAT Nicolle Rantanen, having been appointed as a casual vacancy and term of office ending immediately before the election of Directors in accordance with clause 10.5 of the Constitution and having offered herself for re-election, be re-elected as a Director of Foresters Financial Limited.

Agenda Item 5

Funeral Benefit Fund Rule B4.34(a)

Resolution 3:

THAT Funeral Benefit Fund Rule B4.34(a) be amended to remove the wording: The right to nominate a Nominated Funeral Director whether pursuant to a fixed price contract or other bona fide funeral or burial contract with a Funeral Director will cease to apply to applications for Fund membership made on or after 1 July 2020. Existing nominations made prior to 1 July 2020 shall continue in full force and effect.

By way of background, fund rules were changed in 2020, effective 31 July 2020, to accommodate comments made during The Royal Commission into Misconduct in the Banking, Superannuation and Financial Services Industry (Banking Royal Commission) that the <u>term</u> "nominated" bonds or the ability to "nominate" a funeral director (or other funeral service provider), may be misleading as people believe they had "prepaid" their funeral, which is not the case. In the time since the Banking Royal Commission, however, there has been no change to law. Thus, there is no law that prohibits the provision of nominated funeral bonds. Moreover, the Foresters Financial Limited (FFL) Constitution, which prevails or overrides other policies and documents, does not purport to prohibit nominated funeral bonds, so this change was unnecessary. The benefit fund rules do not strictly need to be changed, because the Constitution prevails, but for the sake of consistency and avoid confusion, FFL is recommending amending the Funeral Benefit Fund Rules in accordance with the highlighted extract of rule B4.34(a) below:

A Member, who is at least 16 years old, may nominate a Nominated Funeral Director, whether pursuant to a fixed price funeral contract or other bona fide funeral or burial contract with a Funeral Director or otherwise, to whom benefit entitlements under a Policy payable on the death of the Member are to be paid. Such nomination is to be made upon the form of nomination as prescribed or accepted by the Society from time to time. The right to nominate a Nominated Funeral Director whether pursuant to a fixed price contract or other bona fide funeral or burial contract with a Funeral Director will cease to apply to applications for Fund membership made on or after 1 July 2020. Existing nominations made prior to 1 July 2020 shall continue in full force and effect.

FFL sought legal advice. Sub-section 16B(2) of the *Life Insurance Act 1995* and paragraphs 33 and 34 LPS 700 (Friendly Society Benefit Funds) are relevant.
